A DISCUSSION WITH... RANJIV ABRAHAM

Chapter Chair – ASIS Qatar , CPP, Certified Instructor

What motivated you to take on the task of revitalizing the ASIS Qatar Chapter?

The motivation came from my corporate experience, where certifications were highly valued across various domains like Routing & Switching, Data Center Infrastructure, and Project Management. However, the Security Systems and ELV industry often carried a stigma and wasn't seen as equally prestigious. I realized that professional certifications could help change this perception and elevate the industry's standing.

Initially, I formed a study group with colleagues to prepare for certifications. When I transitioned to a new role for career growth, I continued this journey alone. That's when I thought about expanding the study group into a broader platform that could support more professionals. This personal journey, combined with my desire to uplift the industry, fueled my determination to revitalize the ASIS Qatar Chapter.

Ultimately, my vision was driven by a sense of responsibility to the profession. Qatar, being a hub for global events and infrastructure projects, needed a strong platform for security professionals to connect, learn, and grow. My goal was to build a vibrant, empowered community that would not only meet today's challenges but also shape the future of the industry.

Tell us about the journey of restarting the chapter.

When I assumed the role of Chapter Chair in early 2023, the chapter was dormant, with only 14 members. The primary challenge was to bring it back to life. I began by reaching out to past members, having one-on-one conversations to understand their concerns and expectations, and crafting strategies to attract new members.

To increase visibility, we launched a website and a LinkedIn page, which helped us engage with the community and highlight the value of ASIS membership. We also organized events tailored to the professional development needs of security



practitioners. These events not only created opportunities for learning and collaboration but also showcased the chapter as a platform for career growth. Collaborating with ASIS International was a game-changer, as it added credibility and expanded our reach. By the end of 2023, membership grew to 61. With consistent efforts and the dedication of our team, by the end of 2024, the chapter achieved an incredible milestone of 140 active members—ten times its original size.

What were the challenges you faced during this process, and what key steps did you take to bring this vision to life?

Building a strong member base was undoubtedly one of the biggest challenges. When the chapter was officially reactivated, we were at ground zero. It took several months of dedicated effort, including countless emails, studying the system, and conducting multiple follow-ups. Reaching out to existing members and potential new contacts involved numerous one-on-one conversations. While it required immense patience, I found it genuinely rewarding to see the community grow. Within 4–5 months, we had overcome the initial phase and were able to establish a functional chapter.

Securing a team of committed volunteers was another critical step. These individuals not only shared the vision but also understood the importance of professional development in the security industry. Their support played a significant role in driving the chapter forward.

Securing sponsorship for a professional, multinational community was a challenging endeavor. In Qatar, numerous communities are organized around specific nationalities, making the establishment of an international community particularly difficult. Convincing organizations of the chapter's potential in a relatively new and evolving market required a lot of effort. However, by highlighting the opportunities and mutual benefits, we managed to onboard sponsors who aligned with our vision. Their support was crucial in enabling us to organize impactful programs and expand our reach.

Each event we organized posed its own set of challenges, from planning to execution. My corporate experience helped immensely in managing resources and ensuring a smooth delivery. Over time, our events gained a reputation for quality, which further bolstered member engagement and attracted new sponsors.

The transformation was certainly challenging, but with a clear vision, persistent effort, and a dedicated team, we were able to build a thriving community that continues to grow and inspire.

How did you feel when the Qatar Chapter won the Outstanding Revitalized Chapter Award at GSX 2024?

Winning the Outstanding Revitalized Chapter Award at GSX 2024 was a truly surreal moment. It wasn't just a personal milestone but a powerful testament to the collective effort of our members and volunteers. The award validated all the hard work, late nights, and sacrifices we made as a team to breathe new life into the chapter.

What made it even more special was seeing Qatar being recognized on the global stage as a key contributor to the security profession. This achievement has given us an incredible sense of pride and motivation. It has strengthened my resolve to continue building a stronger, more impactful chapter that not only serves its members but also inspires others across the region.

What are your thoughts on the future of the ASIS Qatar Chapter?

The future of the ASIS Qatar Chapter is extremely promising, and we are focused on building on the strong foundation we've established. We are committed to continuously enhancing the professional reach of our participants. Study groups for certifications including CPP, PSP, and PCI will remain a priority, making sure our participants stay ahead of industry trends and are equipped with the abilities

needed to excel in the security industry. We also plan to increase the outreach of projects like Women in Security and NextGen to foster a more inclusive community.

Finally, sustainability is fundamental. We're focusing on team innovation and developing a succession plan within the chapter. This will ensure that the chapter stays resilient and capable of serving its members for future years.

That's a great roadmap, Ranjiv. Any final thoughts or message for aspiring security professionals?

I would encourage every security professional to invest in their personal and professional growth. The industry is evolving rapidly, and staying ahead requires continuous learning and networking. Organizations like ASIS provide a unique platform to connect with like-minded professionals and access resources that can propel your career forward.

For those in Qatar, I invite you to join us at the ASIS Qatar Chapter and be part of a journey that is not only professionally rewarding but also immensely fulfilling.

Remember that your career goals should never take a backseat. Life will always be filled with project deadlines, family commitments, and countless responsibilities. Yet, in this ever-competitive and challenging world, finding time for personal growth is not just a choice—it's a necessity.

Valuable insights contributed by our community

AI-based Airport Video Analytics: Revolutionizing Security and Operations

AI-based video analytics (VA) is revolutionizing the way airports manage security and operations. By using advanced algorithms to analyze CCTV footage, AI-driven systems are helping airports tackle security challenges while also enhancing operational efficiency and passenger experience. Despite the numerous advantages, implementing these systems present several challenges, particularly around security and privacy.

One of the key contributions of AI-based VA is its ability to improve security. AI systems can detect suspicious behaviors, identify potential threats, and even recognize faces from a watchlist at various airport touchpoints, such as screening checkpoints. This significantly enhances threat detection and response time, helping prevent potential security breaches. In addition, perimeter protection systems monitor restricted areas, ensuring that unauthorized access is immediately flagged. AI also aids in managing crowds by tracking congestion at critical points, such as checkpoints and gates, reducing the risk of overcrowding and ensuring smoother passenger flow.

Operational efficiency is another area where AI-based VA is making a notable impact. Systems can track queue lengths and waiting times at check-in counters, security, and boarding areas, providing real-time insights to optimize staffing and reduce bottlenecks. AI can also monitor vehicle traffic, identifying illegal parking and recognizing license plates, which helps enforce traffic rules around the airport. Furthermore, baggage monitoring and AI-assisted way-finding provide better service to passengers, improving their overall airport experience. In terms of safety, AI systems are capable of detecting smoke or unusual temperature fluctuations, adding an additional layer of fire and safety monitoring.

However, deploying AI-based video analytics in airports is not without its challenges, particularly concerning security and data privacy. The use of facial recognition technology raises significant privacy concerns, as sensitive data needs to be handled in compliance with regulations like the General Data Protection Regulation (GDPR).



In addition, the cost of upgrading hardware and integrating advanced AI software can be prohibitively expensive for some airports, particularly when dealing with older CCTV systems that may not be equipped to support AI-driven analytics.

Another challenge is the accuracy of AI systems. Machine learning algorithms require extensive datasets to improve accuracy, and in the early stages of deployment, false alarms may occur more frequently. To mitigate these issues, airports can implement pilot programs to test AI-based systems in smaller, controlled environments before full-scale implementation. Additionally, the targeted training of personnel is crucial for ensuring that staff can effectively use and manage the new technology.

Budget constraints can also be overcome by phasing hardware upgrades and software integration, allowing airports to spread the cost over time and make the implementation of AI-based VA more financially feasible. Moreover, strong data protection frameworks should be established to address privacy concerns and ensure that all AI-driven systems comply with local and international regulations.

As airports continue to evolve, AI-based video analytics will play an increasingly central role in enhancing security, improving operational efficiency, and offering better experiences for passengers. By addressing the challenges around data privacy, cost, and system accuracy, airports can unlock the full potential of this transformative technology.
